92Q NASHVILLE'S "SEAN GOOD ERYKAH BADU GOODIE MOBB" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WQQK ("Station"), at 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday, on the station website at www.92qnashville.com or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the 92Q's "SEAN GOOD ERYKAH BADU GOODIE MOBB" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. <u>Text</u>: Send a text message with the keyword <u>GOOD</u> spelled correctly to 68683 during the Contest Period. All entries must be received by 9:59pm CT on OCTOBER 29TH, 2021 to be eligible to win. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest.
