92Q NASHVILLE'S "SEAN GOOD ROARING LOUD FEST" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WQQK ("Station"), at 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday, on the station website at <u>www.92qnashville.com</u> or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the 92Q's **"SEAN GOOD ROARING LOUD FEST"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents, excluding dual Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio. **Void where prohibited by law.** Employees of Cumulus Broadcasting LLC, its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate.  Contest Period. The Contest entry period will begin at 6:01pm CT on OCTOBER 11 2021 and will run weekdays from 6:01pm through 9:59pm CT on OCTOBER 15 2021 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. How to Enter. To enter:

<u>Text</u>: Send a text message with the keyword GOOD spelled correctly to 68683 during the Contest Period. All entries must be received by 9:59pm CT on OCTOBER 15, 2021 to be eligible to win. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone

phone numbers, identities, or any other methods will void that participant from further participation in the Contest.

- 4. **Winner Selection.** On or about 10:00pm weekdays during the Contest Period, Station will select one (1) entry to win a Prize (as defined below) in a random drawing from among all valid entries received by Station as of the date and time of that drawing. The winning entrant will be contacted using the telephone number used to submit the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.
- 5. Verification of Potential Winner. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disgualified for any reason, Station may award the applicable prize to an alternate winner by any method determined by Station in its sole discretion from among all remaining eligible entries or callers.

If any prize or a portion of any prize is postponed, cancelled, or otherwise unavailable due to disease, epidemic, pandemic, quarantine, any acts of government and/or any reason that is beyond the control of Station or any Sponsor, then no substitution shall be provided. Station and any Sponsors make no representation or warranty about the safety of any prize. By accepting and using a prize, each winner acknowledges and assumes all risks of accepting and using the prize, and any other risks associated with the prize.

- 1. Entry Conditions and Release. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

- 10. Limitations of Liability. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
