WQQK "B LOVE ON THE LAKE ONLINE GIVE-A-WAY" CONTEST OFFICIAL RULES

The Station will conduct the **WQQK "B LOVE ON THE LAKE ONLINE GIVE-A-WAY"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Online: Visit the Station's website <u>www.92Qnashville.com</u> during the Contest Period, click on the "Contest" link, click on the "B Love on the Lake 92Q Ticket Give-A-Way!" Contest link, and complete an entry form. All entries must be received by 10:00 am CST on November 14 2021 to be eligible for a chance to win a prize. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disgualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant.
