# WQQK-FM'S "BOOM BOX LIVE ON-SITE GIVE-A-WAYS" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WQQK-FM ("Station"), 10 Music Circle East, Nashville, Tennessee 37203, during available business hours Monday through Friday, on the Station website www.92QNashville.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **WQQK-FM's "BOOM BOX LIVE ON-SITE GIVE-A-WAYS"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
  - Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 30 days and whose immediate family members or household members have not won a prize from the Station in the last 30 days a prize valued at \$500 or more in the **30 days**. Void where prohibited by law. - 2. **Contest Period.** The Contest entry period will begin at 5:00 PM CT on Saturday, December 18 2021 and will run through **11:00 PM CT on Saturday, December 18 2021** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** Remote Broadcast: Attend a remote broadcast conducted by Station on Saturday, December 18 2021 from 5:00 PM CT through 11:00 PM CT at The National Museum of African American Music located at 510 Broadway, Nashville, TN 37203 and complete an entry form by way of a raffle ticket. Limit one (1) entry per person per remote broadcast. All entries must be received by the deadline stated at the remote broadcast.
- 4. **Winner Selection.** On or about every half hour during the live broadcast/contest period on Saturday, December 18 2021, Station will select SIX (6) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
