## WQQK-FM'S "BLACK VIOLIN REGISTER TO WIN" CONTEST OFFICIAL RULES

The Station will conduct the **WQQK-FM's "BLACK VIOLIN REGISTER TO WIN"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

## 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 30 days and whose immediate family members or household members have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the 30 days. All entries must be received by 12:00 PM CT on Thursday, February 3 2022 to be eligible for a chance to win a prize. - 4. **Winner Selection.** On or about 12:00 PM CT on Thursday, February 4 2022, Station will select three (3) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
