## WQQK-FM'S "KAPPA ALPHA PSI AFTER AFFAIR ONLINE REGISTER TO WIN" CONTEST OFFICIAL RULES

The Station will conduct the WQQK-FM'S "KAPPA ALPHA PSI AFTER AFFAIR ONLINE **REGISTER TO WIN**" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries must be received by 11:59 AM CT on Friday, January 7 2022 to be eligible for a chance to win a prize. **Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use.** Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the entrant may be disqualified.
