## WQQK-FM'S "92Q - WWE SUMMER SLAM" CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. The Contest entry period will begin at 12:00 AM CT on Monday, July 18, 2022, and will run weekdays from [start time each day] until [end time each day] through 11:59 PM CT on Friday, July 22, 2022 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

  - <u>On-Air</u>: Listen to the Station weekdays during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners must call the Station at (615) 737-1033. Caller number seven (7) to the Station, as determined by the Station in its sole discretion, will be entered for a chance to win. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
