

92Q'S "MARY J. BLIGE LOWER BOWL APP" CONTEST
OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WKDF-FM ("Station"), owned and operated by Cumulus Broadcasting LLC, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday, on the Station website www.1033country.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **92Q's "Mary J. Blige Lower Bowl App" Contest** (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. 92Q App: Download the free 92Q App via the App Store or Google Play, during the Contest Period, click on the "Contest" link, click on the "The 92Q App Is The Place To Win Mary J. Blige Tickets" Contest link located on the home page of the app, and complete an entry form. All entries must be received by 11:59pm CT on April 17, 2025, to be eligible for the Prize drawing. **Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use.** Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Failure to respond to the initial verification contact within one (1) day of notification will result in disqualification and forfeiture of the prize.
