92Q'S "JURASSIC WORLD REBIRTH ADVANCE SCREENING WEB" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WQQK-FM ("Station"), owned and operated by Cumulus Broadcasting LLC, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday, on the Station website www.92qnashville.com, or by sending a self-addressed, stamped envelope to the above address.

Eligibility. All entries must be received by 11:59pm CT on June 22, 2025, to be eligible for the Prize drawing. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple participants are not permitted to share the same email address.
