

92Q's "MAXWELL URBAN HANG SUITE CRUISE QUALIFIER APP WINNING WEEKEND" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WQQK-FM ("Station"), owned and operated by Cumulus Broadcasting LLC, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday, on the Station website www.92qnashville.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the 92Q's "Maxwell Urban Hang Suite Cruise Qualifier App Winning Weekend" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. This Contest is open only to legal U.S. residents, age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last 30 days, or a prize valued at \$500 or more in the last 30 days, and whose immediate family members or household members have not won a prize from the Station in the last 30 days, or a prize valued at \$500 or more in the last 30 days. **Void where prohibited by law.** Employees of Cumulus Broadcasting LLC, its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. 92Q App: Download the free 92Q App via the App Store or Google Play, during the Contest Period, click on the "Contest" link, click on the "It's Your Last Chance To Qualify For The Maxwell Urban Hang Suite Cruise!" Contest link located on the home page of the app, and complete an entry form. All entries must be received by 11:59pm CT on September 14, 2025, to be eligible for the Prize drawing. **Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use.** Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
